2022 COST OF INSIDER THREATS

Research Overview

The report, commissioned with The Ponemon Institute, surveyed over 1,000 IT security practitioners across North America, Europe, Middle East, Africa, and Asia-Pacific on the frequency and cost of Insider incidents. This is an annual research series first conducted in 2016 and a follow up to the last report published in 2020.





TRIPLE THREAT: THREE TYPES OF INSIDER THREATS

Not all insider threats are alike. Here's a breakdown of the three main types—and what they're costing organizations.



TYPE OF INSIDER	% OF INCIDENTS	COST PER INCIDENT	TOTAL COST TO ORGANIZATIONS
Negligent insiders	56%	\$485k	\$6.6 million
Malicious insiders	26%	\$648k	\$4.1 million
Credential insiders	18%	\$805k	\$4.6 million

DEFENSE SPENDING

Since 2016, responding to an insider threat incident has grown far more costly.






TIME IS MONEY

When it comes to insider threats, time is money. Yet it's taking companies longer than ever to contain incidents when they occur.

Annualized Cost



Insider incidents take an average of 85 days to contain.
(up from 77 days in 2020)



INDUSTRY MATTERS

The costs of insider incidents varies by type and organizational size.

- Large organizations with a headcount of more than 75,000 spent an average of \$22.68 million to resolve insider-related incidents
- Those with a headcount of 500 or less spent an average of \$8.13 million



Financial services and services organizations bear highest average costs managing insider threats

Based on our interviews, the top three technologies that result in the greatest cost reductions are data loss prevention, privileged access management and user and entity behavior analytics.

Privileged Access Management (PAM)	60%

Insider Threat Management (ITM)	41%
